Your company has the opportunity to compete for honors in the construction industry's premier annual awards program recognizing the outstanding merit shop projects of the year. Join your fellow merit shop companies to be recognized as "the best of the best" in the construction industry.

The EIC award honors all construction team members, including the contractor, owner, architect and engineer. Submitted projects are judged by a panel on complexity, attractiveness, unique challenges overcome, completion time, workmanship, innovation, safety and cost.

All award winners will be recognized at the October 2024 awards celebration at the National Aviary in Pittsburgh. The ceremony will feature a multi-media presentation highlighting the Eagle award winners, as well as an elegant printed program highlighting each award-winning project. A company representative must be present to receive their award(s).

ELIGIBILITY & CRITERIA

Each entry must follow the entry requirements outlined in this award application.

ABC Membership Required:

Any general contractor or subcontractor member in good standing of Associated Builders & Contractors of Western PA may enter. Projects completed through a joint venture must include a document outlining the ownership percentage and responsibilities of each partner. Include the document with the Project Information section. If the majority partner is an ABC member but not all partners are ABC members, only the majority contractor is eligible to enter. If your project was completed by a joint venture and not all parties are ABC members, email eic@abc.org for eligibility requirements.

Project Safety:

A company that experiences a safety-related fatality of a direct employee in the United States within the current program year is NOT eligible for an Excellence in Construction award. If a subsidiary is a direct ABC member versus part of a larger holding company member, then the subsidiary with a safety-related fatality is not eligible, but another subsidiary of the same holding company may be.

No project that involves prime, multi-prime or subtrade contractors with a safety-related fatality is eligible to be considered for an award.

ABC National Winner:

Those who receive awards at ABC Western PA 2024 Excellence in Construction Awards are there by eligible to compete on a national level. We highly recommend keeping a copy of your application on hand for it can be useful when applying to ABC National later in the year for a chance to be nationally recognized at the ABC National's 2024 Excellence in Construction Awards.

DATES & DEADLINES

December 31, 2023 – Date by which construction of the submitted project must be completed

September 9th – Deadline to submit the final application. All projects must be submitted in person or via mail. Mailing address for submissions is ABC of Western PA 2360 Venture Drive Gibsonia, PA 15044

Week of September 16th – All applicants will receive an email detailing the results.

October 3rd— Winners will be celebrated at the Annual Excellence in Construction® Awards Banquet in Pittsburgh, PA.

GENERAL CONTRACTING/CONSTRUCTION MANAGEMENT

□ Mega-Projects

All projects regardless of type more than \$100 million.

□ Commercial

Office buildings, banks, retail facilities, hotels and mixed use.

□ Community/Public Service

Philanthropic projects that enhance the community, using substantial resources donated by the contractor.

☐ Federal Government/ Military

All projects owned by the federal government, with the exception of transportation infrastructure and utilities.

☐ Health Care

Hospitals, assisted living, nursing homes and other licensed medical facilities.

☐ Historical Restoration/ Renovation

Restoration of buildings registered as historical, or eligible to be registered as historical.

□ Industrial

Manufacturing plants and facilities, refineries and similar types of construction.

□ Infrastructure

Heavy Streets, highways, parks, dams and bridges.

□ Institutional

Projects owned by schools, churches and local govt., with the exception of health care facilities.

☐ Pre-Engineered Building

Institutional, shopping centers, banks and manufacturing plants Public Works/ Environmental Water treatment plants and sewage treatment plants.

□ Renovation

Non-historical, existing buildings where more than 50% of the contracted dollar value was used for renovation or restoration.

□ Residential

Residential, including independent living retirement communities.

□ Special Projects

Construction not specifically referred to in the above categories. Examples include theme parks, zoos, skate parks, water parks and other unique types of projects.

ENTRY REQUIREMENTS

Overall Presentation and Conformance to Entry Requirements: 5 POINTS

Each entry must be presented in a 1" three-ringed binder not to exceed 10"x13"; use tabs with a label for each of the sections; indicate company name, project name and entry category on the spine and cover of the binder; you must include the entry forms as the first section of your entry; all documents included in the binder must be on 8" 1/2 X 11" sheets.

Contracted Scope: 10 POINTS

Ensuring legibility when selecting font design and size, provide a description (**no more than one full page via PDF**) of the scope for this project with the following information: type of construction, size of project, contract value, length of project, percentage of labor that is self-performed and any subcontracted work performed by fellow ABC members. Describe the opportunities you provided to the construction community to participate based on merit.

Project Narrative: 30 POINTS

Ensuring legibility when selecting font design and size, provide a description (no more than four full page via PDF) indicating why this project is special and why it qualifies for an EIC award.

The focus of the narrative should be the construction (i.e. erection, installation, modification, grade footprint, etc.) of the project. Be sure to include the following items:

- Describe any innovative programs relating to quality control;
- Describe any innovative programs relating to scheduling;
- Describe any value analysis/engineering process used on the project;
- Indicate any special obstacles you overcame in completing the project;

Projects entered into the Community / Public Service categories may include up to five pages, with the fifth page being a separate page describing why the project qualifies for the category. Include a description of the resources donated by your company.

Photography: 8 POINTS

Submit up to 10 high-quality photographs in jpg or png format only. It is recommended to include photos that are relevant to the challenges and solutions outlined in the narrative. To obtain maximum points, include the "in process" photos for new construction and "before and after" photos for restoration/renovation projects. A brief description should accompany each photograph. In addition to the printed photos included in your binder, you must provide a non-returnable Flash Drive with all photos. Files should be a minimum of 300 DPI resolution and in jpg format.

Photographer's Use Authorization: Applicants must obtain the rights from their photographer to reprint the photographs without limitations. Any liability for copyright infringement shall be borne solely by the applicant

REQUIREMENTS CONTINUED

Project Safety: 31 POINTS

No project that involves a prime, multi-prime, subcontractor or any trade-related work with a safety-related fatality is eligible for an Excellence in Construction Award. You must complete the separate Project Safety section of this application (page 9). You must also include your company's OSHA Form 300 (project specific, if available) for the year(s) the project was under construction with personal information redacted.

- Include the additional documents requested on the Project Safety Form,
- In order to be eligible to win an award at ABC National, the company must sign the Drug-and-Alcohol-Free pledge found at www.drugfreeconstruction.org.
- In order to be eligible to win an award, the company must have a written Safety and Health Policy Manual

References: 15 POINTS

Include up to 10 letters of recommendation via PDF from third-parties involved with the project, such as the owner and design team. If the owner is unable to provide a letter of recommendation due to company policy, upload a letter from the owner on their letterhead stating they are unable to provide a reference.

- General contractors must submit letters from at least the owner (or the general contractor's
 prime contracting entity, if not the owner) and the architect. If submitting in an industrial category,
 general contractors must submit letters from at least the owner (or the general contractor's prime
 contracting entity).
- Specialty contractors must submit a letter from at least the general contractor. If not working under a general contractor, specialty contractors must submit a letter from at least the owner.
- Second and third-tier subcontractors must at least submit a letter from their prime contracting entity.

OPTIONAL OPPORTUNITIES

Supplemental Materials: 2 POINTS

Provide any miscellaneous supporting materials such as diagrams and other graphics, media coverage, awards, and promotion, **up to five single-sided pages**.

AQC Contractor: 2 POINTS

If your company has achieved ABC's Accredited Quality Contractor (AQC) credential in the current program year, upload a PDF copy of the company certificate. The certificate must indicate the chapter that you are submitting your project through because the AQC credential is chapter-specific. If necessary, a copy of the certificate may be requested by emailing aqc@abc.org. Please note that requests will be processed in the order in which they are received; be sure to put your request in early.

STEP Safety Management System: 2 POINTS

If your company is a STEP participant, upload a PDF copy of the company certificate(s) from the current program year, as well as any year(s) the project was performed. If your company does not have an electronic copy of your STEP certificate(s), contact eic@abc.org. Please note that requests will be processed in the order in which they are received; be sure to put your request in early.

PROJECT SAFETY FORM

A company that experiences a safety-related fatality of a direct employee in the United States within the current program year is NOT eligible for an Excellence in Construction award. Notification:

Attendance:

At least one representative from your company will attend the awards banquet to accept your award.

Entry Sample Release:
